I acknowledge that sailing can be a dangerous sport and all those taking parting the event do so at their own risk and responsibility.

Declaration: I agree to indemnify all officers or agents of the Clarence River Yacht Club Inc. and any other committee associated with this Event. I agree to be bound by the ISAF Racing Rules of Sailing, the prescriptions and special regulations of the AS (except as any of these are altered by the sailing instructions) and by the sailing instructions, and in consideration for my entry in this event.

Safety Equipment: My boat complies with AS Safety Regulations Category 5 for races with limited rescue availability in enclosed waters. I agree the Clarence River Yacht Club Inc. is not responsible for the seaworthiness of a yacht whose entry is accepted or the sufficiency or adequacy of its equipment.

Insurance: Each participating boat shall be insured with valid third party liability insurance and a minimum cover of \$10,000,000 per event or equivalent.

Non Members - Guest Membership: For the duration of this event, you are deemed a Guest Member of the Clarence River Yacht Club.
